

Minutes of the Deanery Synod held at St Mary's Hanwell with Facebook livestream on Tuesday 5 July 2022 doors opened 7pm for meeting 7.30pm

Attendance: In-person 36 + 3 guests; livestream 72 views at 6 July 2022

Welcome and Worship.

Revd. Andrew Dand, Rector at St Mary's Hanwell, welcomed everyone to the meeting and led the meeting in a short act of evening prayer including two worship songs on the guitar and a reading.

Business Items

Presentation of Accounts

Margaret Cobley, Treasurer, presented the examined accounts for the year ending 28 February 2022. The accounts were adopted.

Diocesan By-election

A notice of a London Diocesan By-election to be held at this Meeting had been issued with two vacancies to the House of Clergy and five vacancies to the House of Laity. No nominations had been received from the Laity and two nominations had been received from the Clergy.

There being two candidates for two vacancies, no vote was required and the candidates were declared elected to serve in the House of Clergy for the Diocesan Synod for a term to 31 July 2024.

Ealing Deanery Mission Fund

Pathways

Revd. Mark Melluish (St Paul's Ealing and Chair of Pathways) gave a presentation on the work of Pathways who is one of London's largest providers of almshouse accommodation for over 55s and

also make grants from its investments including the money used to provide grants from the Ealing Deanery Mission Fund. The Mission Fund benefits from this arrangement because the investments used to provide the Mission Fund grants are part of a larger portfolio and so may produce a larger income than if they were managed on their own. However, the criteria for projects which would be eligible for grants from the Mission Fund is not the same as the criteria for projects which would be eligible for grants directly from Pathways.

The five presentations gave us an indication of the breadth of the projects for which mission bids had been made and enabled us to celebrate the mission activity taking place in the deanery.

Over £22,000 was available in the Mission Fund. Some projects had requested less than £2,000; and two projects agreed to reduce their request to less than £2,000. The Synod was therefore able to approve in block grants of the agreed sums to each of the 14 projects.
